Project Summary: CalRecycle has edited the following summary to reflect the approved grant project: It is our intent to construct a crumb rubber molding facility in Chico, CA in 2016. Presently, there are very limited mold manufacturing facilities operating in California. We have invested heavily in new tooling for new and improved product offerings, which should offer us greater volume for production this year. Our production is currently limited by our partners, other molding operations. Even with two separate molding companies molding our products for us, they continue to under-perform and cannot keep up with our demand. This not only presents a problem for existing production demands, but greatly limits our ability to expand product lines and offer new tire derived products. Our intent is to build a facility that not only can produce our expanded product line(s), but to allow us to develop more new products made with recycled waste tire rubber. It's been long recognized that there is a limited amount of crumb rubber molding operations in California, moreover in the North State there is the noticeable absence of production facilities, while there are several tire processors in northern California. This further demonstrates the opportunities for the location of such a facility. This new facility will incorporate wherever possible automated system for product production along with a strategic selection of products. While molding is a relatively simple process, the automation of this process is not without complications and will require expertise to help us create the first automated recycled crumb rubber production plant in CA. We will hire several specialists in this industry for this endeavor. We are purchasing (4) 400 ton hydraulic presses which will provide some of the highest output possible. This higher than normal output will provide us with a compelling competitive advantage over other products from existing facilities, in that labor expenses and production costs will remain at a minimum, providing for volume production at the lowest rates possible.
