Project Summary: CalRecycle has edited the following summary to reflect the approved grant project: RCDWR is relocating the current Lamb Canyon PHHWCF/CAF facility and is proposing to expand the footprint of the facility to accommodate for RCDWR's HHW collection services and the Load Check program. This expansion will increase HHW services in the central region of the Riverside County (see Exhibit 3 – Lamb Canyon PHHWCF/CAF Site Plan). The existing Lamb Canyon PHHWCF is 33 feet by 56 feet facility with three (3) conex boxes connected to each other. The expansion of the facility will consist of a 72 feet by 85 feet concrete pad, two chemical storage containers, an office building, a supply storage container, and a portable car port.

The improvements include installation of a new hazardous materials storage locker and a metal awning over the storage area for propane tanks/cylinders. These upgrades and improvements will result in increased program operations efficiency, expanded facility capacity, and improved worker safety.

The Cold Canyon Landfill HHW facility will be expanded by over 8,000 square feet and in include a new hazmat storage building, forklift and signage.
