With over 6300 slips for marine vessels the county has a significant unmet need for flare disposal. Current vendor proposals indicate meeting the one time disposal need will cost in excess of \$50,000.

This will include specific materials often mishandled in the waste stream (propane cylinders, fluorescent bulbs, marine flares) as well as basic facility information, including days and hours of operation, common HHW materials accepted and options for reuse of these materials. The campaign may include print media, radio, television and possibly outdoor media to ensure all population segments of the Town are reached. The Town will also hold a minimum of three propane cylinder and one marine flare one-day collection events, promoting the use of refillable 1 lb. propane cylinders and the ReFuel Your Fun (RFYF) campaign as well as marine flare alternative "distress signals" by distributing coupons for up to \$20 off the purchase of a refillable 1 lb. propane cylinder or a distress signal in lieu of a disposable cylinder and marine flare respectively.

**Project Summary:** The Agency will promote the existing HHW program of permanent collection, one day events, and reuse facility, in addition to retailer collections and curbside and retail batter collection programs, for the full grant term. Special emphasis will be on the new refillable 1lb propane gas cylinders to promote the local retailers who sell and refill them, as well as parks where there are new collection receptacles. Public education efforts will be broad and use a wide variety of tools, including press releases, articles, billboards, print ads, social media, truck signs and others. Additionally, the Agency will develop and install a new educational, hands-on exhibit in its mobile 4R Kids Exhibit that focuses on EPR programs for propane cylinders, paint, mercury thermostats, and other HHW products. Personnel will focus on retail sales and refilling of 1lb propane cylinders, and special collection events and locations for new collection for disposables, including seasonal collection events at local recreational parks. The increased use of refillable cylinders will be promoted through a variety of incentives, including coupons and select exchange events. Additionally, the Agency will expand the collection of reusable HHW for redistribution by purchasing a collection storage cabinet for the Corning HHWF, purchase PPE for HHWF operations, and fund annual 8-hour HAZWOPER refresher training for staff.
