**Project Summary:** CalRecycle has edited the following summary to reflect the approved grant project: Ventura County Public Health Department (VCPH) will allow the County to address a food recovery effort, by tackling the main obstacle that currently prevents programs from widespread donating. VCPH and Ventura County Environmental Health will develop Edible Food Recovery Guidelines with a focus on hot food collection, which is notoriously difficult. These guidelines will provide a greater level of assurance to potential donors that they are participating safely in a recovery effort. In addition, VCPH will provide leadership and resources to develop a coalition that brings together a network of stakeholders, with the primary goals of ending hunger in Ventura County and diverting food from landfill disposal. VCPH will also create an outreach program that Environmental Health Inspectors can use to encourage donations from businesses throughout the region.
